STATUTORY DECLARATION



I, (NRIC NO.) of do solemnly and sincerely declare as follows:-

- 1)(NRIC NO.) ofand died on (“the Deceased”), is the policy owner of a life insurance policy no. (“said Insurance Policy”) issued by Great Eastern Life Assurance (Malaysia) Berhad (93745-A) (“the Company”);
- 2) I am the Life Assured of the said Insurance Policy, issued by Great Eastern Life Assurance (Malaysia) Berhad (93745-A) (“the Company”);
- 3) I undertake to apply for the Grant of Probate (“GP”) or Letters of Administration (“LA”) of the Deceased’s estate and to provide the Company with a certified true copy of the GP or LA upon issuance of the same;
- 4) Pending issuance of the GP or LA, I hereby authorize the Company to effect the change of ownership of the said Insurance Policy from the Deceased to me. I agree and confirm that I shall hold the said Insurance Policy as the policyowner as well as trustee for the sole benefit of the Deceased’s estate. I shall observe and perform all the obligations under the said Insurance Policy.
- 5) If administration of the Deceased’s estate is not given to me for any reasons whatsoever, I undertake to abide by any and all instructions from the lawful personal representative of the Deceased’s estate in relation to the said Insurance Policy. I shall inform the Company if I am not appointed as the lawful personal representative of the Deceased’s estate and the Company is authorized to effect the change of ownership of the said Insurance Policy from me to the lawful personal representative, without further reference to me. I further undertake to pay all the benefits received by me prior to the administration of the Deceased’s estate and the appointment of the lawful personal representative to the lawful personal representative once the same is appointed, if the same is not me;

- 6) In consideration of the Company agreeing, at my request, to effect the change of ownership of the said Insurance Policy from the Deceased to me, I hereby undertake to indemnify and keep the Company fully indemnified from and against any and all losses, actions, claims, suits, demands, proceedings, damages, compensation, fines, costs and expenses including legal costs in taking and defending any legal actions that the Company may incur directly and indirectly arising out of or in consequence of agreeing to my request therein;

- 7) I make this declaration in full knowledge and awareness of the Company's reliance on this declaration as the basis of allowing the change of ownership of the said Insurance Policy from the Deceased to me;

- 8) I am fully aware that it is a criminal offence to make a false declaration.

And I make this solemn declaration conscientiously believing the same to be true, and by virtue of the provisions of the Statutory Declaration Act 1960.
