4. In consideration of the Company agreeing at my request to effect the change of ownership of the Takaful Certificate to the Person Covered, i hereby:
 - a) agree that I shall not challenge or hold the Company liable for any action(s) taken by the Company in relation to the Takaful Certificate based on the instruction given by me;
 - b) agree to discharge the Company from all liability in respect of any payment to be made under the Takaful Certificate by the Company to the Person Covered, including without limitation, any refund of excess contribution, payment of surrender value, payment of maturity proceeds and payment of death benefits;
 - c) undertake to indemnify and keep the Company fully indemnified from and against any and all losses, actions, claims, suits, demands, proceedings, damages, compensation, fines, costs and expenses including legal costs in taking and defending any legal action that the Company may incur directly or indirectly arising out of or in consequence of agreeing to my request herein to effect the change of ownership of the Takaful Certificate.
5. I make this declaration in full knowledge and awareness of the Company's reliance on this declaration as the basis for the Company to proceed and effect the change of ownership of the Takaful Certificate to the Person Covered.
6. I understand and am fully aware that it is a criminal offence to make false declaration
